CIRCULAR NO. 61 - OF 2017-2018

Subject:- Filling up the posts of Library & Information Officer (General) in the National Library, Kolkata advertisement for deputation (including short term contract) basis.

One posts of Library & Information Officer (General), (G.C.S. Group 'A' - Gazetted, Non-Ministerial) in the pay scale of Rs. 67700-208700/- Level-11 in the National Library, Kolkata, a subordinate office under the Ministry of Culture, is required to be filled by deputation (including short term contract) basis. The educational qualifications and experience, eligibility criteria, etc. required for the post are as under:-

1. Educational Qualifications & Experience:-

Essential:

- (i) Master's degree of a recognized University or equivalent.
- (ii) Master's degree or equivalent in Library Science of a recognized University/Institute or equivalent.
- (iii) Five years experience in a recognized Library.

Note (a):-Qualifications are relaxable on the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note (b):- The qualification (s) relating to experience is/are relaxable at the discretion of the Union Public Service Commission in case of candidates belonging to the Scheduled Castes or Scheduled Tribes, if at any stage of selection the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

Desirable:

- (a) Five years experience in computerization of a recognized library.

2. Eligibility : Officers of the Central/State Governments/Union Territories/recognized research Institutes/public sector undertakings/Universities/semi-government/statutory or autonomous organization.

- (a) (i) Holding analogous posts (LIO(Language) on regular basis in the parent cadre/Department
OR
(ii) Assistant Library & Information Officer (Language) with eight year's service in the grade rendered after appointment thereto on regular basis in posts in the scale of pay of Rs.44900-142400/- Level-7 or equivalent in the parent cadre/Department
And
(b) Possessing the educational qualifications and experience prescribed for direct recruits under column 8.

Note (a):

- (i) The departmental officer in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment by deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- (ii) The period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years.
- (iii) The maximum age limit for appointment by (deputation including short-term contract) shall be "Not exceeding 56 years" as on the closing date of receipt of application)
- (iv) The provision for absorption will be applicable in the case of Central/State Government and Union Territory Government officials only.

Note (b): The crucial date for determining the eligibility of the applicants will be counted after excluding the first date of publication of the vacancy/post in the Employment News.

3. Pay:-

The pay of the selected candidate will be regulated in accordance with the Ministry of Finance O.M. No. 10(24)-E.II(B)/60 dated 04.05.1981 as amended from time to time.


Deputation period: - The deputation period shall ordinarily not exceed 3 years.

It is requested that the contents of this circular may be brought to the notice of all concerned and the application of suitable eligible and willing officers, in the attached Proforma (Annexure-I) duly signed by the candidate (s) and countersigned by the Employer together with Bio-data and Upto-date character Roll Dossiers/APARs of the applicants may be forwarded to the Director General, National Library, Kolkata. Where there is no practice of maintaining confidential reports, a certificate to this effect may be furnished by the competent authority. Applications received after the last date or found deficient in any manner will not be entertained. While forwarding the applications, it may be verified and certified that the particulars furnished by the officer(s) are correct and that no disciplinary case is either pending or contemplated against him.

Note:- All the applicants are advised that they must submit their application along with (i) Cadre clearance certificate. (ii) Integrity certificate. (iii) Vigilance certificate (iv) Annual confidential reports/APAR (for last 5 years) (v) Statement of Major/Minor penalties, if any imposed upon the officer during the last 10 years, within last date of receipt of application through their Employer/Cadre Controlling Authority.

The candidate selected for appointment will be required to join duty immediately after selection. The maximum age-limit for appointment by transfer on deputation shall not exceed 56 years as on the closing date of receipt of applications.

An officer once nominated will not be permitted to withdraw on his own. The last date of submission of applications will be 60 days to be counted from the next date to the advertisement of the vacancy Circular in the Employment News.


